## Waiver - Please sign and date the waiver below to complete your registration.

In consideration of the acceptance of my (or that of a minor for whom I am signing as a guardian) registration for the 2019 Believe Walk®, I (the undersigned), intending to be legally bound for myself and the minor child(ren) for whom I sign as guardian, and our personal representatives, spouse, assigns, heirs, and next of kin, do hereby: (i) understand the dangers and inherent risks of injury that may result from participation in a walking and running event (which risks include, but are not limited to, actions of other people and their dogs, lack of hydration, weather, or other natural conditions) and do hereby assume all risks of participating in the event; (ii) certify that I am (or the minor for whom I am signing as a guardian is) physically fit and sufficiently trained for participation in this event, and I have (or the minor for whom I am signing as a guardian has) not been advised otherwise by a qualified medical person; (iii) certify that I am responsible for my own actions, the actions of my dog, and the actions of any minor for whom I have signed as a guardian or who is in my care before, after, and while I or they are on the walking/running area and surrounding area including without limitation the pre-race and post-race areas and surrounding streets and parking locations and I will be cautious of other people and participants around me; (iv) waive all of my rights (and those rights of a minor for whom I am signing as a guardian) and forever release and discharge the organizers, participants, emergency medical technicians (if any), sponsors, and owners of the Believe Walk® and all of their directors, officers, agents, and employees from all liability, any and all loss or damage, and any claims or demands made on account of injury to me or my property arising out of or related to my participation (or the participation of my dog or a minor for whom I am signing as a guardian) for any event or occurrence related to the 2019 Believe Walk®; (v) further covenant and agree not to sue any of the persons or entities mentioned above in paragraph (iv) for any of the claims, losses, or liabilities that I have (or a minor for whom I am signing as a guardian has) waived, released, or discharged herein; (vi) indemnify, defend, and hold harmless the persons and entities in paragraph (iv) from any and all liabilities or claims made by other individuals or entities as a result of my actions (or the actions of my dog or the minor for whom I am signing as a guardian) during this event; (vii) agree that I will at all times comply with the Redlands Municipal Code, which states in pertinent part that any person owning or having charge, custody, control, or possession of any dog shall not permit such animal to run at large, or to run loose or unrestrained in, along, or upon any public street, sidewalk, or place (Ord. 1926 § 2, 1986: prior code § 57301); (viii) understand that refunds are not available should I (or the minor for whom I am signing as a guardian) fail to participate in the Believe Walk®; and (ix) expressly grant full permission to Stater Bros. Charities® and its sponsors and permittees the right to use my (or the minor for whom I am signing as a guardian or a minor or dog who is in my custody during the Believe Walk®) name, likeness, image, voice, biographical information, photographs or video recordings taken during the event in any promotional, advertising, marketing or other purposes relating to promoting the Believe Walk® in all media and other outlets, whether online or in print, without consideration.
